


Workplace Safety - November

 - One assailant apprehended
 - One investigation pending
 - One knee strain while running to disband an altercation
 - One vehicle accident caused by other party
 - Recordable Injuries 2% decrease year over year
 - Lost Time Injuries flat year over year
 - Days Away 23% increase year over year





November 2021 Year To Date RII Rate per 100 Employees






November 2021 Year To Date LWC Rate per 100 Employees






November 2021 Year To Date Days Away Rate per 100 Employees






November 2021 Year to Date Preventable Accidents Rate per 100,000 miles


November 2021 Year to Date High Severity Rate per 100,000 miles


