Workplace Safety - October


- Three (3) Recordable Injuries (RII), Two (2) Lost Workday Cases (LWC), Nineteen (19) Days Away from work
  - Injured Employees:
    - One Maintenance employee and Two Bus Operators
    - One employee wounded on finger by incidental needle stick exposure.
    - One employee received multiple physical injuries from slipping and falling on rocks.
    - One employee strained knee while stepping up bus grains.
  - Recordable Injuries 27% decrease year over year
  - Lost Time Injuries 35% decrease year over year
  - Days Away 33% increase year over year





Days Away (Rate in 100's of Days)





























### **October 2024 Year To Date Hazard Resolution Rate**






### **October 2024 Year to Date Open Overdue Hazards**

■ Number of Open Overdue Hazards as of 8/31




### October 2024 Year to Date High Severity Rate per 100,000 miles






  - 10 Open and Overdue

















### Rail Maintenance – October 2024
